Shambhunath Municipality Office of the Municipal Executive, Kathauna, Saptari has allocated funds towards the costs **Shambhunath Namuna Nagar Pariyojana** and intends to apply part of the funds to cover eligible payments under the Contract for 1/T/MUN/2078/079. Bidding is open to all eligible as per Section V of bidding document.
2. Shambhunath Municipality Office of the Municipal Executive, Kathauna, Saptari invites electronic bids from eligible bidders for the construction of **Shambhunath Namuna Nagar Pariyojana** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 2,00,00,000**
 - Minimum Work experience of similar size and nature: **At least a project with value 2,00,00,000 in words two hundred million.**

Bidders, submitting their bid electronically, should deposit the scanned copy of bank voucher of non refundable fee Nrs. 5,00,000 shall be uploaded by the bidder at the time of electronic submission of bid.

6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp before 12:00 hours on 2079-10-06. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on 2079-10-06** at the office of Shambhunath Municipality, Kathauna, Saptari Procurement Unit. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 12,00,000 which shall be valid for 30 days beyond the validity period of the bid **(i.e. 150 days)**
8. If the last date of purchasing and /or submission falls on a government holiday, then the next
